- a) In 2023the Security **Council** voted to extend the **mandate** of the United Nations Mission for the **Referendum** in Western Sahara (MINURSO) until 31 October 2023, calling on the parties to resume **negotiations** in good faith towards a **mutually** acceptable political **solution** for the region.
- b) Any person who is the subject of arbitrary detention, arbitrary **temporary** confinement, or **miscarriage** of justice shall have the right to **compensation**. The law shall determine the conditions and modalities of the **compensation**.
- c) On 17 April 2018 Algeria established an exclusive economic zone (EEZ) off its coasts by Presidential Decree No. 18-96 of 2 Rajab 1439 corresponding to 20 March 2018. On 20 June 2019, a communication from Algeria was sent. It was addressed to the Italian embassy and the Spanish embassy in Algiers to show their eligibility in Algeria's exclusive economic zone.
- d) **Public** economic **law** course aims at analyzing the general principles of **public** intervention in **economy** by addressing the legal frameworks that govern it, the powers and the role of public **authorities** and their relationships with **private organizations**.
- e) Algiers recognized the United States by the signing of a peace treaty **on** September 5, **1795**. The United States recognized Algeria on July 3, 1962, when President **John Kennedy** issued a **congratulatory message** to the Algerian people upon their independence from France.
- f) Contrary to the popular view in Western legal scholars, which often refers to the Dutch jurist, Hugo **Grotius**, as the 'father of international law', Islamic legal scholars identifies Muhammad **al-Shaybānī**/ as having, in that regard, preceded Hugo **Grotius** by some eight centuries with the compilation and systemization of the rules of **Islamic** international law under a specialized subject area of Islamic law termed al-Siyar, which covers the laws of war and peace according to the Shari'ah.
 - g) **President** Abraham **Lincoln** honored **Emir Abdelkader** as a great humanitarian for saving thousands of **Christian** lives, including the personnel of the U.S. **consulate** in **Damascus**, in 1860.
